Description : The tender is a part of the "Hong Kong First Green Rehabilitation Bus Pilot

Scheme", fully supported by The Hongkong Bank Foundation and organized by The Conservancy Association. The scheme aims to subsidize the purchase of electric rehabilitation buses (Green Rehabus), installation of charging facilities, and provision of technical support and monitoring to social welfare organizations. After the pilot is completed, the project results will be shared with social welfare organizations and stakeholders to facilitate the continued promotion of electric

rehabuses.

The work includes providing AC and DC Chargers for various Green Rehabus models and conducting assessments, designing circuit arrangements, completing installation works for EV charging facilities, and providing maintenance services for NGO parking sites in privately owned locations and private/public car parks
